## II. General Principles of Data Processing

The Data Controller processes personal data in accordance with the following legal acts and principles:

- **Regulation (EU) 2016/679 of the European Parliament and of the Council** (General Data Protection Regulation, **GDPR**).
- Act CXII of 2011 on the Right of Informational Self-Determination and Freedom of Information (**Infotv.**).

The scope of data processed, the purpose of processing, and the legal basis are defined separately for each data processing activity (see Section III).

## III. Data Processing Activities

## IV. Rights of the Data Subject

Angel Gold Produkció, as the Data Controller, ensures that you, as the data subject, can exercise the following rights:

1. **Right of access:** You have the right to obtain confirmation as to whether or not personal data concerning you are being processed, and, where that is the case, access to the personal data and further information (purpose, categories, recipients, duration).
2. **Right to rectification:** You have the right to have inaccurate personal data rectified or incomplete data completed.
3. **Right to erasure ("Right to be forgotten"):** You have the right to obtain the erasure of your personal data without undue delay, for example, if the data is no longer necessary or you withdraw your consent (unless processing is based on a legal obligation).
4. **Right to restriction of processing:** You have the right to request the restricted processing of data (e.g., instead of erasure) if you contest the accuracy of the data or the processing is unlawful.
5. **Right to data portability:** Where processing is based on consent or a contract and is carried out by automated means, you have the right to receive the personal data concerning you in a structured, commonly used, and machine-readable format.
6. **Right to object:** You have the right to object to processing based on legitimate interests at any time. In the case of direct marketing, the objection automatically stops the processing.
7. **Right to withdraw consent:** Where processing is based on your consent, you have the right to withdraw that consent at any time, which does not affect the lawfulness of processing before the withdrawal.

## V. Legal Remedies

- **Complaint to the Data Controller:** If you believe that Angel Gold Produkció has violated your data protection rights, you can file a complaint with the Data Controller (contact details: Section I). We will investigate the complaint and provide a substantive response within 30 days.
- **Supervisory Authority (NAIH):** You have the right to lodge a complaint with the Hungarian National Authority for Data Protection and Freedom of Information (NAIH).

- **Judicial Remedy:** You may file a lawsuit against the Data Controller before the court competent for the Data Controller's registered seat or, at your choice, the court competent for your place of residence or habitual abode.
